The granting of this licence is subject to the following conditions:

- 1) Betting World (Pty) Ltd must have legal possession of all premises specified in this licence, including the URL. Furthermore, all online and land-based facilities must be kept safe, secure and in good working order.
- 2) Betting World (Pty) Ltd shall provide and maintain guarantees to the MER of at least the average monthly betting levies during the previous financial year. The MER may approve or determine another amount for the guarantee from time to time.
- 3) Betting World (Pty) Ltd shall submit to the MER periodically, as stipulated by the MER from time to time, a deliverable report containing all information required in the format approved by the MER.
- 4) Betting World (Pty) Ltd shall ensure that internal control procedures of the company are submitted to the MER prior to commencement of operations and are adhered to.
- 5) Betting World (Pty) Ltd shall on a continuous basis, satisfy the MER of sufficient measures taken to ensure that no persons under the age of 18 years have access to any online and land-based betting facilities authorised in terms of this licence.
- 6) Betting World (Pty) Ltd shall have an electronic record keeping system, certified in terms of applicable South African National Standards (SANS) and approved by the MER, with access to the system provided and maintained for the MER, at the cost of Betting World (Pty) Ltd.
- 7) Betting World (Pty) Ltd must ensure that they have legal rights to conduct betting activities on sporting events or other contingencies, where applicable. Furthermore, all contingencies offered on online and land-based betting facilities authorised in terms of this licence must be approved by the MER.
